


RIGHT TO BELONG AND BE HEARD



The rights of the child apply to every child without discrimination of any kind, irrespective of the child's individual characteristics, or those of a parent or legal guardian, including race; skin colour; sex; language; religion; political or other views; national, ethnic or social origin; property; disability; birth or other status.

UN Convention on the Rights of the Child





The UN Convention on the Rights of the Child guarantees every child and young person the right to live and grow up in safety.

The Convention has been ratified by all countries of the world except the United States of America. In Finland, the Convention was enacted in law in 1991 and has been in force ever since.



The four general principles of the UNCRC:

No child should suffer discrimination.

Article 2

The best interests of the child must be a primary consideration.

Article 3

The child has the right to life, survival and development.

Article 6

The child has the right to have their views considered.

Only 49% of children and young people aged 10–17 who responded to the questionnaire on children's rights feel that their views are considered too rarely in matters that concern them.

However, the UN Convention on the Rights of the Child points out that every child has the right to belong and be heard.

Children can express their views orally, in writing or in print, in the form of art or even by taking part in a demonstration. Children also have the right to freedom of expression, association and assembly.



The purpose of the UNCRC is to protect the wellbeing and development of children. Here are some rights related to belonging and being heard:

Article 12

Children's views must be given due weight in accordance with their age and maturity.

Article 13

Children have the right to express their opinion. Children have the right to receive information.

Article 15

Children have the right to organise and operate in associations.




UN Convention on the Rights of the Child

The UN Committee on the Rights of the Child monitors the implementation of the Rights of the Child. The Committee thinks that Finland should, for example:

- Ensure that children and adults are informed about the rights of the child
- Minimise discrimination, for example through awareness-raising campaigns
- Improve children's digital literacy
- Ensure that children in foster care are informed of their rights
- Ensure that all children receive accurate information about sexual health
- Ensure that all children have equal access to education
- Ensure that children have free leisure activities in all municipalities








What is the meaning behind the theme?
